<u>ORDER</u>

As per the letter read above the Director of Fisheries has furnished a project proposal "Enhancing Entrepreneurial Skills of SAF activity groups and Strengthening of monitoring system of SAF" under Gender Equality and Women Empowerment Policy" 'through Society for Assistance to Fisherwomen (SAF), for according administrative sanction for an amount of Rs 10 lakh in the year 2018-19 from budget provision in the head of account 2405-00-120-98 (Non Plan) to Executive Director, SAF for the implementation of the project.

The components of the project includes:

- 1. Exposure visit :- The leaders of different successfully running units coming under Apex Federation, Garments federation Fish Federation and Food Federation are selected for the exposure visit starting from Uralunkal Labour Contract Society, Vadakara and ends in Apparel Park Tiruppur. 40 leaders from successful units will be selected for the exposure visit. The total budget allocated for exposure visit is Rs.5.50 lakh.
- 2. ARMIS support :- This component ensures the sustainability of ARMIS and to update the system based on the new requirements. The purchase of new 9 tablet PC's for the new mission Co-ordinators, software uploading based on new requirement, server support SIM recharge and other maintenance and support. The total budget allocated for exposure visit is Rs.4.50 lakh.
