ORDER

As per the Government Order read as first paper above, Administrative Sanction was accorded for the Project Proposal for setting up of Seed rearing unit for Pearl Spot (Etroplus Surantensis) in Poyya farm with a total cost of Rs. 151 lakh under the Head of Account 2405-00-101-87-34-OC(P) Setting up of Nurseries. As per the Government Order read as 2nd paper above, the Head of Account 2405-00-101-87-34-OC(P) had been modified as 4405-00-101-95-34-OC(P) for the implementation of the project.
