## **ORDER**

The National Co-operative Development Corporation (NCDC) as per the letter read above, conveyed approval for providing financial assistance of Rs. 3121.50 lakh (Rs. 2621.50 lakh as loan and Rs.500 lakh as subsidy) to the Government of Kerala, for the implementation of Integrated Fisheries Development Project (IFDP) 2019-20, by Kerala State Cooperative Federation for Fisheries Development Ltd. (MATSYAFED), through Primary Fishermen Cooperative Societies at a block cost of Rs.3774.66 lakh. Accordingly, as per the Government Order read as 2nd paper above, administrative sanction was accorded for the NCDC assisted IFDP Project 2019-20 at a block cost of Rs.3774.66 lakh.

- 2) As per the Government Order read as 3rd paper above, an amount of Rs. 655.375 lakh (25 % of loan advance) from the budget provision of 2020-21 provided under the Head of Account 6405-00-195-99(P) and as per Government Order read as 4th paper above, an amount of Rs.2066.13 lakh (loan Rs.1532.580 Lakh + Share capital Rs.433.545 Lakh+subsidy- Rs.100 Lakh) had been released to Matsyafed for implementing IFDP 2019-20.
- 3) The Director of Fisheries, as per the letter read as 5th abov e, has informed that the Matsyafed has requested to release the balance amount under

subsidy component amounting to Rs.632.77 lakh (Government of India Subsidy -Rs.400 lakhs + Government of Kerala Subsidy other than fishing inputs-Rs.232.77 lakhs) under the head of account 2405-00-103-82 (P). The Director of Fisheries has requested to accord sanction to release an amount of Rs.100 lakhs from the budget provision under the Head of Account 2405-00-103-82(P) for the subsidy component and to allot the balance amount of Rs.532.77 lakh by additional authorisation.

- 4) Considering the request of the Director of Fisheries, Government, a s per the Government Order read as 6th paper above, authorised an amount of Rs.632.77 Lakh as additional expenditure under the Head of Account 2405-00-103-82-33(P).
- 5) Further, Government are pleased to accord sanction to the Director of Fisheries to release the balance of subsidy component **Rs.632.77 lakh (Rupees Six crore Thirty Two lakh Seventy Seven thousand only)** to the Matsyafed, for the implementation of NCDC assisted Integrated Fisheries Development Project (IFDP) 2019-20, under the head of account 2405-00-103-82-33(P), subject to the following terms and conditions of fund release.
- 1.The amount shall be transfer credited to PSTSB account in compliance of G.O.(P.)No.62/2018/Fin dated 16/4/2018.
- 2. The instructions stipulated in Circular No.8/18/Fin dated 30/1/2018, Circular No. 84/2008/Fin dated 09/12/2008 and G.O.(Ms.)No.93/2020/Fin dated 11/9/2020 shall be complied with.
- 3. The Fisheries Department shall furnish duly authenticated detailed component wise statement of Expenditure and Utilisation Certificate in the prescribed formats appended to the G.O.(Ms.) No.4/2020/Fin dated 09.01.2020.
- 4) If there is unutilised amount at the end of this financial year, that should be refunded to the government during the financial year itself.
